BARC had been sent out for bid and the ITS Working Group will meet in conjunction with the Resource Sharing WG to review proposals and recommend to the Board the 2016 BARC services provider. Should there be a one-year contract while SCRLC investigates offering the service in-house? How is ILL shifting between books (returnables) and articles (non-returnables)? How is Twitter being used for ILL? Should there be a fee structure in place for BARC use (it was mentioned that AskUs 24/7 and some of the HLSP resources are cost-share). M-C Lindbloom would like to convene a task force to re-examine Council fees charged. The NY 3Rs article on demand white paper was mentioned.
