- Lorie Brown Lorie announced she's retiring in June and they have hired a new person to fill her position. Her name is Haliegh Mikolajczyk and she's starting in June so Lorie will have time to do training.
- Lucy Yang Lucy announced that she's retiring on February 24, 2024. They
  have new library clerks in place and Lucy has been training them. Classes in
  TC3 started the day before this meeting and they are working to get student
  workers in place. She has been working with Gregg who will be taking over for

- Elise Thornley Elise announced that the annex has been fully transitioned and they are now in one building and there is a high-density storage facility. The third floor of the building is being remodeled and it's progressing well. Hopefully, it'll be done by next year.
- Erin Wilburn Erin shared that classes start next week and they are in the process of making text book selection for their new system. SUNY added CUNY to their ILL so they have new borrowing partners which doesn't apply to Broome Community College as they don't participate in ELD.

#### Spring 2024 Program Update

Christine reported that the location will be at the FLLS building on Dryden Road. The SUNY Cortland campus was used when we worked with CLRC on a joint in person meeting because it was the middle point. For this meeting, it will be just SCRLC because Anna Dobkowski has retired at CLRC and they are working to hire a new person. Program topics will include a presentation by Mark Sullivan on the new Crosslink (formerly Cross Share) platform they're working on. We are also planning for a panel discussion from libraries who have left OCLC. An update from Maria on ELD will be included and a tour of a library (possibly the Africana Studies library) may be included in the afternoon.

#### Fall 2024 Program

At this time, it's not knows if we'll have a joint with CLRC. It will depend on the new hire and what their plans are. We may need to consider working with RLRC or maybe PALCI in PA. We will keep everyone posted on this possibility.

#### **DEIJA workshop/presentation for Resource Sharing**

We are still considering the plan to bring together multiple library types for discussion on what they do for DEI especially as it pertains to resource sharing activities. This would include something from school libraries and how they engage in resource sharing.
