# **HLSP Field Visits for 2025/2026**

Christine announced that she is planning to do another round of Field Visits and is expecting to start reaching out to HLSP members in early Fall to get them scheduled before the weather becomes challenging for travel.

# **HLSP Grant Program Update**

Christine announced that final report for the 2024/2025 grants are nearly complete and she's working with a couple members to finish the process.

Christine also announced that she's starting to work on the applications for the 2025-2026 grant cycle and should have things ready sometime in September.

# **Electronic Resources**

Christine announced that the STAT!Ref subscription was renewed in June with a few titles that weren't used removed from the subscription and a few new titles added to replace those titles. A notice with the new titles was distributed in early July and usage will be monitored this year. Christine also announced NEJM Evidence usage has been low though we've only been subscribed for 7 months. It does appear to be increasing. And, our usage of the NEJM subscription has remained at nearly the level it was last year despite the fact that Lourdes was not included in our subscription for most of the year. This was due to the fact that all member hospitals are now using the subscription though some have low levels of usage. We will continue to monitor the usage to determine if the increase in usage continues.

Christine also reported that the Ovid Usage decreased this year due to Lourdes not participating in the cost share of these items. We did pick up Auburn but they are smaller than Lourdes and do not have comparable usage.

### **Lunch and Learn update**

Christine shared that she is working on the Lunch and Learn programs for this year and she is currently looking at three that relate to AI in hospitals. One will address how AI is used in health care setting, another will look at ethical considerations for AI in health care and the third might be comparing Chat GPT or Open Evidence to a search in Cochrane.

Christine also shared that she reached out to Laura about a program on pharmacy topics and Laura shared information for Neyda. The plan is for Neyda to do a program sometime in the Fall.
