She accidentally locked herself out of her phone while trying to use a screen reader to determine if documents are accessible, so be aware if you are using screen readers.

Rachel- They are hosting the Smithsonian Voices and Votes exhibit and they are hosting events surrounding that. They got a grant to digitize women's suffrage materials through SCRLC and they are highlighting that collection at associated events. They are giving a tour at SCRLC's annual meeting.
