#### **Around the Table**

Caitlin shared that there isn't much going on at Cornell. They are now participating in the Hathi Trust sharing pilot. Currently, they are able to lend material (ie, article, chapters) from them.

Haleigh shared that they are wrapping up programming and are planning their advocacy trip to Albany in February.

Deborah shared that their ILL Assistant is now working solely in Ill full time. Also, Cornell is now delivering to FLLS twice a week.

Sarah Trencansky shared that their semester end in two days and they are wrapping things up for the semester.

Virgilio shared they are working on last minute requests and wrapping up the ILL returns.

Gregg shared that they are working on budgeting which is projected to be flat so there is a big lift on that front.

Sarah Shank shared they are working on end of semester things and also on reserves for the next semester.

Christine shared that SCRLC is working on the Plan of Service (due April 2026) and transitioning BARC to an in-house program. Both are on the agenda for this meeting.

#### **BARC Transition Update**

Sarah Shank shared that the user accounts are now set up and details for messaging and routing are being addressed. We're planning for a soft launch to take place in January. We will provide training for libraries as we're using a new platform. Specific dates and details will be shared as soon as possible.

### **SCRLC Plan of Service 2026-2031 Update**

Christine shared that SCRLC is busy working on the Plan of Service for 2026-2031 which is due April 2026.

There was a review of the Resource Sharing Elements that were included in the 2021-2026 Plan of Service. Many still apply and some changes were recommended. Also inclusion of the BARC transition was recommended for the 2026-2031 Plan.

### **Resource Sharing Joint Meeting for 2025/2026**

Christine shared that she is working with Sophie at CLRC and they are planning for a program in March or April on libraries of things and makerspaces. Details will be shared as soon as possible.

### **Other Topics**

Deb shared that she has noticed that IC hasn't been borrowing or lending much and Virgilio shared that they are not part of OCLC. That led to a discussion on how FLLS (and others who use OCLC) can participate with IC for ILL.
