### PROPOSED MEMBERSHIP DUES RESTRUCTURING

At their September 23, 2016 meeting, the SCRLC Board of Trustees voted to move the proposed membership dues restructuring document forward to the membership for ratification at the 10/21/16 annual meeting. As per the SCRLC Bylaws Section 12.2.2,

"Dues for member institutions shall be recommended by the Board of Trustees and ratified by a majority vote of the member institutions voting."

As part of the proposal, the Bylaws will be changed to reflect the new membership structure.

GOVERNING MEMBERS Name Change: Formerly called "FULL MEMBERS." Governing Members can vote and participate in all Council programs. Includes Academic, Hospital, Special Libraries, Library Systems.

### **ASK US 24/7 VIRTUAL REFERENCE SERVICE**

Cost share is based on the library's materials budget. SCRLC does not charge the FTE/per capita fee than WNYLRC accesses to non-consortial direct members.
