February Meeting Minutes – approved without change

SCORA

- **LibGuide Update** – Christine announced that the SCORA Tab is up and running and invited everyone to check it out.
- **Increasing participating colleges/universities** – There was discussion on ways to improve membership including doing a short video to post online and to check with Rochester LRC to see how it is used and promoted there.

Interlibrary Loan (ILL)

- **User Group Meeting Fall 2023**
 - **Prison Library Panel Discussion update** – Christine announced that she will be on a phone conference with Corine F. Leone on Friday.
 - **Exhibit - [Behind the Wall: Art and Writing from Prison](#)** – This program is offered by the Durland Alternatives Library and one of their programs is correspondence and programs for prisoners. There was discussion on how this exhibit or something like it could be incorporated into our User Group Meeting. If we do a hybrid program using Owls, and exhibit could be onsite. If it's strictly online, we could maybe tap into a different service the program provides. Christine will look into how this can be incorporated into the UGM.
 - **Perhaps CDL and Internet Archive** – There was discussion about how the Internet Archive case was decided and what that will mean to libraries. Some thoughts on how this subject can be addressed include bringing in a speaker from IA; finding a library that is still pursuing CDL despite the decision; finding a library that changed its mind after the decision and possibly turning it into a panel discussion.
 - **"A Day in the Life..."** – Looking at different types of libraries is an interest. Christine reported that she has reached out to the Lily Dale library and is waiting for a response. The Durland Alternative Library might be a possibility here.

- **Delivery** – There was much discussion on delivery including a suggestion that it might be a good topic for the Spring when budgets are being developed. Ben mentioned that IC stopped using ELD and switched to UPS/FedEx due to costs. Lucy mentioned TC3 dropped to 3 deliveries per week. Elise mentioned that 3 days was one of a few options for SUNY schools. We might want to bring in someone from ELD to address the price changes and Maria could provide an ELD update.
- **Other** – Workplace burnout is a timely topic and not likely to go away anytime soon so a presentation could be beneficial. – Bring in someone from a medical library to address how they handle ILL issues
- **Spring 2024 Program**
 - **Topics** – The Fall User Group Meeting discussion developed many topic ideas and more than can fit in a half-day session. Some of the topics might work for Spring if we can't fit them into the Fall.

DEIJA workshop/presentation for Resource Sharing – Virgilio announced that the DEIJA Advisory Committee is now the DEIJA Advisory Committee and this change was voted on at the last meeting to include and A for Access which is an important factor for many marginalized groups.

- **Book Discussion** – The DEIJA Advisory Committee will pursue this topic.
- **Diversity Audits in Library Collections** – Christine shared that she attended a webinar by a medical school in Texas that performed one in their library on the topic of meeting the needs of trans people. Christine will look into this topic and provide more information.
- **Another topic** – Virgilio mentioned bringing different library types together to share DEIJA activities that they are doing and provide information about how their efforts have worked. Examples include school, public and medical libraries.

On a positive note, they have added libraries from Idaho and Washington State.

Virgilio – Students have been decorating for Spring and that makes the library space fun.
